## Agenda 1:

- The Association has submitted five proposals for **NRHM-PIP** to Health & Family Welfare Dept. Govt. of Gujarat. Four of them were accepted for inclusion in state plan and were submitted to Government of India for final approval. Unfortunately the proposal was not accepted and clarification was asked regarding some points. It was suggested to resubmit the fresh proposal after necessary clarification of inquired points.
- **Post graduate certificate course:** 2<sup>nd</sup> batch of PGDHMS has started and 21 students completed for the course.

# Agenda 3:

- There was delay in indexation of Healthline journal in Scopemed due to fund related constrains.
- The secretary has contacted all Head of the Department across Gujarat for their willingness to opt for management of Healthline journal for 3 years. There was only single correspondence received regarding same matter. Community Medicine Dept., GCS Medical College had shown willingness for management of journal for next 3 year as per TOR given by association. The proposal was unanimously accepted.
- It was proposed that token amount, as minimum as possible to meet the printing expenses, should be charged as manuscript processing charges from the authors submitting their manuscripts to Healthline Journal.

• Dr. Vaibhav Ramanuj was unanimously selected as election officer for the upcoming election of governing body at Joint Annual Conference of IAPSM-GC (XXII) and IPHA-GC (VI).

### Agenda 5:

- Financial management for the state conferences of IAPSM-GC and IPHA-GC was discussed and decided to put forward the following guidelines in the upcoming GBM.
  - The organizing secretary of the annual state conference of IAPSM-GC may use the support of PAN number of IAPSM-GC for financial management of conference. He/she will be responsible for submitting the required documents for the final audits of the conferences to the Chartered Accountant of association.
  - Hiring of permanent Chartered Accountant for audit of accounts of association and state conferences of IAPSM-GC.
